

I then realized my calling on that Easter Sunday Morning of April 3, 1994 at 11:00am. It has become such an obsession of mine since that snowy morning. Having been divorced and living alone. I had all of the time, patients, and money, needed to dedicate myself to answer the biggest question of all. "WHERE'S HEIDI"? I knew many of the people of the community and of the Town well.

These are the facts that are comprised of an accumulation of information provided by the Oswego Sheriff Officials, Television and News Paper Medias. This includes Personal Interviews and discussions with concerned, scared, and often frustrated Citizens of our Community.

WHO IS HIEDI M. ALLEN?

Hiedi M. Allen is an 18 year old white female. Date of birth 9-14-75. She has been missing since Easter Sunday morning of April 3,1994. She is 5'11", 145 lb., Blonde Hair, and Hazel Eyes and may be wearing glasses.

She was last seen at the D&W Convenience Store located on the corner of route 104 and route 104B of New Haven, New York. She was wearing Jeans, a sweatshirt with plaid SU on the front, and white sneakers.

Heidi lived in New Haven, New York her entire life. She lived with her Grandmother rather than with her parents for unknown reasons. Heidi was a Freshman for one year at the Mexico H.S. of Mexico, New York. She then was enrolled into the OSWEGO CATHOLIC H.S. of Oswego, New York. The events leading to this change of school is uncertain. Perhaps for the same reasons why so many other good parents are switching their children from Public to Private Schools these days.

Where is all this money that the Public schools are suppose to be receiving from the New York State lotto that they promised, and we voted for. And our property taxes are still going up.

She attended Onondaga Community College. She worked at the D&W Convenient Store on the corner of route 104 and route 104B of New Haven, New York. This store is owned by Matthew Duell, Christine Duell, Christine's parents?.

## WHERE'S HIEDI?

Who was the last to see Heidi? This person could have been anyone that Sunday morning. And keep in mind. What you are about to read could have been YOU, that Sunday morning.

In Richard Thibodeau's own words to me on 8-18-1996. ~~He recalls the Thibodeau's own words to me on 8-18-1996.~~ He recalls the following critical time before Heidi presumably disappeared.

The last person to see and purchase items from Heidi in the D&W Convenience store was Richard Thibodeau. In Richard's own words he recalls the following:

Upon arriving to the D&W Convenient store. Richard observed a red XR7 Sports Car parked in front of the store window and the ice machine. Richard proceeded to park in front of the double doors facing towards the cashiers window behind the red XR7 Sports Car. Richard noticed Heidi looking out the window as he proceeded to turn the engine off, and to enter the store.

Richard got out of the van and was confronted by an unknown person at the time, holding the door open for Richard to enter the store while Richard responded verbally or in a manner of, "Thanks". Then Richard entered the store and this other person in turn, proceeded out of the store in passing.

This person was later identified by the Oswego Sheriffs as John Swenszkowski who owned the red XR7 sports car and had admitted to being there. Richard purchased two packs of cigarettes. Paid for the items and left the store through the front doors. Richard then got into his van and proceeded to follow John to the route 104 exit of the store parking lot. John Swenszkowski sped right on to route 104 towards Oswego in a fast manner. Richard then proceeded to exit left onto route 104 towards Mexico to go home to pick up Teresa Crawford Wallice (his girl friend), and their children to go to Teresa's grandmother's (Leona Corey's) house they went for an Easter Holiday family dinner.

The following events proceeded with the arrival of the following people:

The first in order to arrive and notice there was nobody there was David Stinson, Pat Granger, and John Glinister. And all three persons were there when the first Oswego Deputy Sheriff had arrived at the Store. The first Deputy to arrive was Deputy Sheriff Richard Curtis after John Stinson had Presumably flagged him down.

Deputy Curtis asked Pat Granger if she had seen a BLUE VAN squealing and burning rubber down route 104B. Because a phone complaint was called in. At that time they notified him that the store clerk was missing. HE WAS THERE INVESTIGATING A DIFFERENT CALL. According to Pat Granger. David Stinson said, "Hiedi's missing! Hiedi's missing"! Deputy Curtis and David Stinson went into the store and briefly searched for the store clerk. Hiedi is presumably missing at this time.

*(How did David know Hiedi was the clerk? She was not on the schedule located behind the counter on the wall. The store originally was scheduled to be closed Easter Sunday.)*

At this time. Deputy Curtis contacted Christine Duell, one of the owners of the store. Deputy Curtis secured the area and presumably called in for backup. And proceeded taking statements from all three people present at this time.

*(Where are Deputy Curtis's notes of their 3 statements?)*

Meanwhile, Chris Duell and Ken Allen had already arrived to the store, when Bret Law returned to the store at 8:10 after Sue Allen called him asking about Hiedi.

*(Where's Waldo?)*

Pat Granger tried to give a statement to Investigator Yerdon but, he would not take a statement from her at all. He pretended to listen to her but, was not writing anything down. She asked him, "Are you going to write anything down?" And he replied "What she was saying had no bearing on what they were doing in their investigation."

*(What was it that Pat wanted to say?)*

STATEMENTS on the Heidi M. Allen case by the Oswego Sheriffs:

According to David Stinsons FIRST STATEMENT the following had been stated by David O. Stinson to Inv. H.G. Yerdon on 4-3-94 at 8:40am as follows:

On April 3,1994 at about 7:10am I got up. I had a cup of coffee and I decided to go to Nine Mile to work out. My wife, Mary, told me to stop and get a newspaper. I left my house at about 7:35am to 7:40am and drove straight to the D&W store. I only live about one mile away. I don't remember passing any cars. I do remember that there were no cars outside the store, (customer's cars). There was two cars there but they were not customer's cars. One was a red station wagon and a white ford that is for sale in the parking lot. I parked next to the outside phone. It was raining out. I walked into the D&W Store. There was no one around, I picked up a Sunday newspaper and I had the exact change but I wanted to give the money to the store clerk. I thought the clerk must be in the bathroom or something. Someone else came into the store for news paper. This person got a newspaper was a W/M middle aged, I did not notice what he was driving. This man left a \$1.50 for the paper and left. I may have been in the store for about 1 or 2 minutes when this man came into the store. Then a second man came into the store for a Sunday paper, just about the same time as the first man was leaving. The second man left 2 one dollar bills on the counter and took 50 cents from the top of counter. At this time there was \$4.50 left on the store counter. My money and the other two men. The second man was also in his fourties (middle aged) and was a W/M. I didn't look at this guys vehicle. Now I have been in the store for 2 or 3 minutes and I had not seen the store clerk yet. I waited another 5 minutes in the store. I am wondering where is this store clerk. I had been in for about total 8 minutes now, I starting looking around to see if I could locate the store clerk. I yelled hellow, no one answered. I checked the two bathrooms and the cooler for the store clerk but did not see anyone. Just about this time PAT GRANGER stopped at the store for \$5.00 worth of gas. PAT came in the store. I used to work with Pat. We talked for a couple of minutes. I told Pat I could not locate the store clerk. I told Pat that I did not want to leave, until I found out that the store clerk had not FALLEN or something. Now Pat and I checked the store out but we did not locate anyone. A new Haven Fireman stopped at the store with some cans to be returned. Now I started to get more concerned about the where abouts of the store clerk. I decided to go outside to look in the store clerks car. The store clerk was not in the car. I look toward the highway, and I saw a Oswego County Sheriff's car coming. I flagged the Sheriff's car down and told the Deputy I had been at the store for a few minutes and could not find the store clerk. I let the deputy take over from this point. I may have been at the store for a total of 15 minutes befor the Deputy came. (Date 4/3/94 Time 1448)

According to Richard P. Thibodeau's FIRST STATEMENT the following had been stated by Richard Thibodeau to Deputy Van Patten on 04-03-1994 at 11:20am as follows:

Today at around 7:30am. I arrived at the D & W Store at Str 104 and Rt104B. I stopped at the store so I could get cigarettes. When I arrived, I saw a new red sports car like a Porche. The car was parked in the closest gas bay facing west. The vehicle was off and there wasn't anyone inside the car. As I was walking inside the store, the driver of the car was walking out with a paper. The man is described as follows; White male, 45-48 years of age, 5'11" . 180lbs, salt and pepper color hair, and glasses. The man was wearing a brown/tan leather jacket. Inside the store I grabbed two packs of Basic cigarettes on the rack above the cooler. I paid the cashier and everything seemed fine. I then left. When I was in route to the store, this Red Sports car passed me also traveling west. When I first pulled into the store, the cashier looked out the window at me. When I purchased the cigarettes inside the store, no one was inside the store with me, or pulled up to the store. When I left. Then the guy left, he was traveling EAST on Rt 104.

According to Patricia A. Granger's FIRST STATEMENT the following had been stated by Patricia A. Granger to Deputy Pitcher of the Oswego Sheriff's on 4-3-1994 (No time indicated.)

On April 3rd, 1994 I woke up about 6:05am. I looked out my bedroom window and I noticed the outside lights were on at the D&W Store. At about 6:15am I let two of my dogs outside. At about 6:25 the dogs were let back inside and I fed them. I took one of the dogs to the kennel. I went back inside my house at about 6:50am. I left my house again and went to the D&W Store at about 7:55am. I was driving a white blazer. I saw the tail end of a car parked to the far left of D&W. It was a dark red. I pulled the blazer to the first pump and there was a tan or grey vehicle also. I went inside. There was a white male with a grey sweatshirt on. He had short brown hair. He was walking around the store. I think his name is Dave. He said I hope you have the right change because I can't find anybody here. He said he had been there about ten minutes, and looked around everywhere. I said she must be here somewhere because there are keys on the back counter. He said I'll go outside and see if there is a car here. He went outside and came back in. He said there was a car outside. We both looked around the store and could not find anybody. Another gentleman had walked inside, wearing a carhart jacket and jeans, dark hair and mustach. Dave went outside and noticed the sheriff's car driving by and flagged Dep. Curtis down. Dep. Curtis took my name and telephone number. I left about 8:07am.

According to John (NMN) Swenszkowski's FIRST STATEMENT the following had been stated by John Swenszlowski's to Investigator R.R. Scruton on 04-04-1994 at 8:30am.

Yesterday April 3rd, 1994 Easter Sunday. I was at my girlfriends house on Hurlbut Rd. T/O Mexico. I was leaving to go home and I looked at the clock on the wall and it was about 6:35am. The clock had not been set forward for the time change and her clock is usually about five minutes fast. I drove to Eggelston Rd. and turned right onto Eggelston Rd. and drove to Route 104. At the intersection of Eggelston Rd. and Route 104 there was a van in front of me. It was a light colored van pretty beat up and rusty. The van turned left onto Route 104 and so did I. The van was very slow so I passed it. I drove to the D & W Store at Route 104 and Route 104B. I went in and I bought two Syracuse Sunday papers and a pack of Marlboro's. I don't know the girl that was behind the counter as I am not a regular customer, but the girl had on a gray (I think) Syracuse sweat shirt. There was no one else in the store that I saw. I paid her and I left. When I was going out the door there was a white male walking into the store. He was about 5'7" or 5'8" tall thin build with a mustache and a 2 or 3 day beard. Also he had a ball cap pulled down low. When I walked passed him. I said Hi and he said something back. I don't know what. When I got outside the van that I had passed was parked in front of me. The first part of the plate number was PU55. I put the papers in my car and opened my pack of cigarettes. I took one out and sat down in my car. I didn't light it, I started my car and the van was starting to pull out also. We both stopped and he waited so I pulled around him and left. I drive a 1993 Mazda Rx7 Red.

According to Christopher Lee Bivens's FIRST STATEMENT the following had been stated by Christopher Lee Bivens to Inv. Fred Ling and Inv. Herbicide Yerden on 4-17-1994 at 6:22pm as follows:

On Easter Sunday April 3, 1994 I was driving to church. I go to church on route 104 in Dugway T/O Albion. I drove by the D&W Convenient store at Rt.104 and Rt. 104B around 8:00am. As I drove by I saw an older full size van that was a LIGHT BLUE. It looked like a Chevy van. It looked like it was between a 1979 to 1988. It looked beat up and had some rust on it. There was no spare tire rack on the van. The van was parked between the two islands like it was getting gas at the first island.

Standing between the store and the first Island was a woman with lt. brown hair. She was struggling with a man that had her in a bear hug from behind. They were both facing away from the store towards route 104B. Another man was walking, toward the van. They both were white males. They both were between 30-40 years of age. They were both around 5'11" tall and they were strong looking. They appeared husky. End of Statement 6:47pm.



## THE EVENTS THAT PROCEEDED

Jim Benningfield arrived 04-7-1994 from Texas. Director of missing persons.

Hiedi Allen's family posted a \$20,000 reward about any information about Hiedi Allen's Disappearance. Posted on 04-13-1994.

On 04-18-1994 200 National Guard Troops arrived to assist in the search for Hiedi Allen.

04-26-1994 Jim Benningfield returned to Texas vowing to return if Allen's body was found or if someone is charged with abducting her. He also speculated that two men were involved in her disappearance. Then he returned to New Haven 05-20-1994. To help with CNN televised segment of the disappearance of Hiedi M. Allen.

On 05-25-1994 Gary was arrested for (drug trafficking)\* charges from Massachusetts and extradited to Massachusetts. Richard was arrested the same day of a felony charge of 1st. degree kid napping.

On 07-22-1994 Gary was arrested for 2nd degree kidnapping of Hiedi Allen.

## THE INVESTIGATION OF THE MISSING HIEDI M. ALLEN CASE

Fred McClean spoke harshly of their accusing Gary and Richard. He claimed they were innocent. Investigator Yerdon said, "How can you say this? You Use to be one of us. Fred replied, "Ya, and that is why I left the force". Detective Wheeler was also present.
